- Concerned Circle Officer will report all operational matters to Excise & Taxation
 Officer (Counter Narcotics Operations)
- > To maintain compete record of Excise Police Stations under his jurisdiction.
- Daily Diaries, copies of FIR, Daily situation reports & others reports to Excise & Taxation Officer (Counter Narcotics Operations) shall be routed through Circle Officer.
- > Active perusal of under trial cases.
- > He will submit weekly case property details to the Deputy Director Admin.
- > Execution of Command & Central over the officials serving at respective Excise Police Station.
- > Discipline, hear applications & all reports shall be routed through him.
- ➤ He shall act as reporting officer for the SHO, Additional SHO, Investigation Officer and other relevant staff of Police Station.
- > Establish close liaison with the local informers & sources for conduction successful operations for connection with drug trafficking.
- ➢ He will inform Excise & Taxation Officer (Counter Narcotics Operations) immediately about all the activates relating to Drug Trafficking occurred in his area of jurisdiction.
- > He will submit correct report to OPS on daily basis.
- > He shall plan operations for the interdiction and surrender of Drug Traffickers in his area of responsibility.
- ➤ Before each operation activity he will inform Excise & Taxation Officer (Counter Narcotics Operations) about the expected time & area of operation.
 - He will maintain list of drug traffickers with their contact & address having in his AOR.

- > He will ensure that all absconders are arrested.
- > He will submit weekly report on case property under his AOR/EPS.
- > He will make it sure that all under trail cases are activity pursued by the concerned official under his AOR.
- > Daily Diaries, copies of FIR, Daily situation reports & others report shall be routed through his office.
- > He will monitor and assist whole procedure of investigation and report to Excise & Taxation Officer (NCW) the same.
- > He will monitor each & every case and malkhana.
- > He will ensure safe custody of malkhana and case properties.
- > He will keep close liaison with concerned DPP.
- > Any other task assigns to him.
