5. In case they wish to resign at any time, a month's notice will be necessary or in lieu thereof one month's pay will be forfeited.
6. They will have to produce a medical certificate of fitness from the Medical Superintendent of the concerned District/ Police Services Hospital Peshawar, as required under the rules.
7. They have to join duty on their own expenses.
8. Their services shall be liable to termination at any time without assigning any reason, before the expiry of the period of probation, if their work during this period is not found satisfactory. In such an event, they will be given a month's notice of termination from service or one month pay in lieu thereof will be paid to them.
9. They can be posted anywhere in Khyber Pakhtunkhwa.

If the above terms and conditions are acceptable to them, they should report for duty to Office of the Undersigned within thirty (30) days of the issuance of this Order failing which this offer of appointment will automatically stand withdrawn.
